## How Can You Become a Member?

During the transition to Family Care in Marquette County, you are eligible to enroll in our Family Care Program if you are currently in a waiver program. If you are on the waiver waiting list, contact the Aging and Disability Resource Center serving Green Lake, Marquette and Waushara Counties for information.

The Aging and Disability Resource Center will assist you in reviewing your options and will enroll you in the program of your choice. Membership is voluntary, and you can enroll or disenroll at any time.

After the transition period in your county, adults will be eligible for Family Care if they:

- are age 18 or over and have a developmental and/or physical disability; or
- are age 65 or over;
- have long-term care needs;
- meet functional and financial requirements; and
- are a resident of Marquette County.

Our Family Care Program is offered in other counties in Wisconsin, so if you move outside of Marquette County you may be able to continue your enrollment.

The new Family Care Program covers your home and community-based long-term care services—and provides you with your own care team to ensure your needs are met.

Family Care in Marquette County is offered by Care Wisconsin, a nonprofit care management organization founded over 32 years ago. Our mission is to support people in their choice to live as independently as possible and maintain quality of life.

As a member of Family Care, you can access Care Wisconsin's local provider network for needed services, such as in-home personal care, medical equipment, assisted living, transportation and help with employment.

We believe you should have a say in how and when your care is provided. That's why we make you the most important member of your care team.

### Member-Centered Approach

Your care team includes you, a care manager/ social worker and a registered nurse. Together, you will discuss what's important to you and what personal goals or long-term care outcomes you want to achieve. You will determine what you are able to do for yourself, what supports you have already and what your needs are.

Using a process called the Resource Allocation Decision method, your care team will create a personalized service plan. The service plan will focus on the outcomes you want and the resources you may need to achieve those outcomes. Together, we will put in place the right services in the right amounts at the right time to support your changing needs.

You also have the opportunity to arrange, direct and purchase some or all of your services through the Self-Directed Supports option.

We are committed to working with you to find safe, healthy and cost-effective ways to meet your outcomes.

### Benefits and Services

Our Family Care Program includes the same long-term care benefits and services you have received from the Community Options Program (COP) and/or Community Integration Program (CIP), as well as some Medicaid services.
